The bid from the Colorado School District Self Insurance Pool for the school's liability insurance increased by 71% for next year, the district is looking for other options. The district's health insurance coverage will increase by 6.5% for next year. The lunch program and our lunch program provider were discussed. Mr. McCracken also discussed with the board about the plans to remodel and install cabinets in the classrooms. The baseball season for Fleming has been cancelled due to the fact there is not enough players to field a team this year. We look forward to having a team next year.
