Superintendent Board Report

May 6, 2013

- Our enrollment stands at 209. The list is enclosed. Our largest classes are 20 (8th, 9th & 10th grades) and our smallest class is 9 (6th grade). Our class size average is: PK-6: 13; 7-12: 18; PK-12: 15.
- ➤ The Attendance report from April is included. Our attendance rate was 93% (Elementary 94%; Secondary 92%).
- The Town Council Meeting was moved to the same date as our meeting. Therefore, I'm not able to attend. However, they were going to talk about a written proposal for "gifting" us the baseball field. I have been collecting estimated increased cost figures for the school. The insurance generally increases \$125/per \$100,000 value. Cameron estimates that he will spend a couple of hours per week in mowing and maintenance of the baseball field, which would come to a total of about \$200/month during mowing season (including salary and benefits). If other maintenance issues arise, like repairing a sprinkler system problem, then that would be added. He is not aware of any sprinkler system issues and says it is working at present. The field includes a press box, bleachers, batting cages, playground, backstop, and fencing. I still need to determine the legal costs of transferring ownership. I will attempt to talk to an attorney before the meeting to get an idea of those costs.
- Summer projects: Plans are to: refinish the gym floors: paint the new gym; clean the rafters in the new gym; and complete some renovation of the FB field. This would include pulling the home bleacher sections apart and pouring a concrete slab underneath the entire bleacher area. We would leave a gap between those 2 sections and cut a window in the concession so it opens towards the field instead of away from the field. We plan to replace the wooden bleacher seating with aluminum seating. We also plan to pour a wide sidewalk that connects the ticket booth to the home stands, and expand the concrete apron around the ticket booth. We have about \$20,000 set aside for this work in this current year's budget. Cameron has priced materials for this improvement. I will price connecting water to the concession, but not sure yet if we have the money for that project.
