# **Superintendent's Report**

June 26, 2012

- The attendance rates for May were: 96% (Elem), 94% (7-12) and 95% for the District.
- ❖ We have completed 2 of our Promethium Board training dates. The 3<sup>rd</sup> one was delayed until August since harvest came early. We had 5 attend the first training and 8 attend the 2<sup>nd</sup> one.
- We are up to near 20 new students that have either verbally or officially committed to attending Fleming this next school year.
- As suggested at the last meeting, I have contacted Dale McCall abut providing some Board member training. It was pointed out that it's been several years since any training has taken place. He is willing to provide training for his travel expenses (he lives in Longmont). We are working on some dates for him to come out and I will keep you posted. He is the Executive Director of the Colorado BOCES Association and does some farming just north of Yuma. He has grandkids attending Lone Star and has provided training for several area boards.
- ❖ I am also beginning to go through our administration regulations to make sure all are updated and match our practice. It will take me some time, and I might check with CASB for some guidance. I want to make sure that our regulations match our practice — or, if not, update the regulation to match what we are doing in reality — if we have the leeway to do so. I have downloaded several updates on the CASB website to give me a start. I will keep you posted on that also.

- I've also enclosed an email from Colorado State Commissioner of Education regarding some upcoming changes in the statewide assessment program.

# Town of Fleming and Frenchman RE-3 School District



#### **BASEBALL FIELD**

The Frenchman RE-3 School District is to pay the Town of Fleming \$1500 per year for maintenance. However, it is agreed that instead of the monetary payment, the School will mow the ball field March through the end of Fleming HS Baseball season.

During March through the end of the Fleming HS Baseball season, the School will do the fieldwork:

- Putting down the base lines, etc.
- Dragging, prep work for games

#### Other Items:

- 1. The Town will provide the chemicals if the school district sprays March through the end of Fleming HS Baseball season. The Town is responsible for weed control at all other times.
- 2. The Town will buy maintenance supplies and materials. Labor for repairs will be by mutual agreement between the Town and District for the period of time between March and the end of Fleming HS Baseball season..
- 3. The Town will pay for trash, sewer, electricity, water, and insurance.
- 4. The Town will turn on water to the Field after the winter season, to keep the grass in good playing condition.
- 5. The school will install a locker in the building to protect School property (i.e. basebalis, chalk, etc.)
- 6. Representatives of the School, Town, and recreation Committee will meet annually in the month of September.
- 7. The School owns some concession equipment that will be transported to and from the Baseball Field.
- 8. There is no PA system at present. The Town or School may install one if either wishes to do so.
- 9. The portable bleachers belong to the School. The Town and School will move them to and from the Baseball Field as needed.
- 10. The School will maintain the restrooms from March through the end of the Fleming HS Baseball season.
- 11. The pitching machine repairs will be equally divided between the Town and the School.
- 12. An inventory will be maintained listing all equipment and ownership.
- 13. The Town will be responsible for maintenance and repair of lighting.
- 14. Any upgrades or changes must be pre-approved by the School Board and Town Council.
